

9TH ANNUAL ROBERT H. DEDMAN AWARD FOR ETHICS AND LAW DINNER (OCT 6)

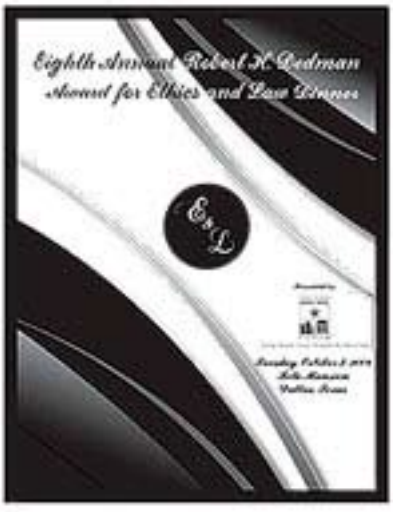
