

## 10TH ANNUAL ROBERT H. DEDMAN AWARD FOR ETHICS AND LAW DINNER (OCT 5)

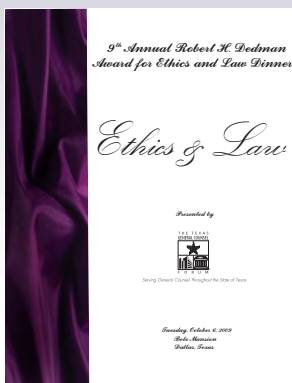
An equally important part of the program is the awarding of a substantial scholarship to a law student currently enrolled at Southern Methodist University Dedman School of Law.
